The Annual IDNS dues for new Registered and new Intern memberships, when joining midway through the year, shall be pro-rated accordingly to the following schedule:

1<sup>st</sup> Quarter: 100%, 2<sup>nd</sup> Quarter: 75%, 3<sup>rd</sup> Quarter: 50%, 4<sup>th</sup> Quarter: 25%.

Other classifications: 100% all quarters.

If a member changes categories within 6 months of the billable date, a credit of 50% of their paid IDNS portion of the dues will be applied to the new category dues, less a \$50 processing fee.

All annual dues for all categories are non-refundable. If a member wishes to terminate membership, no refund will be provided.

IDNS do not accept credit card payments.
